


Why?

DO NOT IGNORE HAZING

Respond, verbally, after speaking with next up the chain

Do not attempt to explain away

OWN THE SITUATION

The event happened

In your program

With your coaches

Involving your athletes

Response

BE IN THE LEAD, NOT TRAILING

Whenever possible, have a comment

- "We are working toward determining what happened and how to best support all of our student athletes."
- "At this time we are still assessing all of the provided information and appreciate your candor as we work toward supporting and protecting our student athletes."

Express, if allowable, the steps you are in the process of

Announce the findings and plan - if legally permissible
