## Beginning the Process

#### **Purpose of Coaches Handbook**

•	To serve as a reference for the coaches, Athletic Department, and other
	school officials who need to be knowledgeable of procedures, policies, duties
	and responsibilities as they relate to the interscholastic athletic program in
	the School District.
•	To serve as a guide in the promotion of a well-planned program of
	interscholastic sports which subscribes to and promotes educational values,
	as expressed in the policies of School District. To
	support High School Athletic Association rules and to fulfill the
	Federal Title IX guidelines.



#### ATHLETIC CODE OF CONDUCT

- Coaches retain the privilege of insisting on proper grooming and dress of each squad member.
- Any athlete involved in any activity that would reflect unfavorably on the school shall be subject to disciplinary action. This could mean expulsion from athletics.
- Gambling, profanity, hazing, and obscene language will be unacceptable at all times.
- Athletes are expected to conduct themselves in an appropriate manner at all school activities.
- 6. Athletes must adhere to the training rules as listed on Pages 12-14.



#### ATHLETIC CODE OF CONDUCT

- Coaches retain the privilege of insisting on proper grooming and dress of each squad member.
- Any athlete involved in any activity that would reflect unfavorably on the school shall be subject to disciplinary action. This could mean expulsion from athletics.
- Gambling, profanity, hazing, and obscene language will be unacceptable at all times.
- Athletes are expected to conduct themselves in an appropriate manner at all school activities.
- 6. Athletes must adhere to the training rules as listed on Pages 12-14.

#### DRESS CODE

We expect our athletes to project a favorable image for our school. Dress must follow the High School handbook rules when athletes are in school. This includes uniforms.



#### **Behavior Unbecoming a Student-Athlete**

Participation in the athletic program is a privilege, and student-athletes are expected to <u>behave in a manner that will reflect positively</u> on their teams and on their school. As representatives of the athletic program and the school district, it is the responsibility of the student-athletes to <u>make positive decisions at school and in the community.</u> <u>Behaviors that violate</u> these expectations and reflect poorly on the student-athlete, athletic program, and school <u>will be met with proportional consequences</u>. Such behaviors will be identified <u>at the discretion</u> of the athletic director and principal.



#### **Behavior Unbecoming a Student-Athlete**

Participation in the athletic program is a privilege, and student-athletes are expected to behave in a manner that will reflect positively on their teams and on their school. As representatives of the athletic program and the school district, it is the responsibility of the student-athletes to make positive decisions at school and in the community. Behaviors that violate these expectations and reflect poorly on the student-athlete, athletic program, and school will be met with proportional consequences. Such behaviors will be identified at the discretion of the athletic director and principal...but may include pictures of using and/or possession of alcohol, tobacco products, drugs, illegal performance-enhancing substances, vapes, or electronic cigarettes, as well as bullying, harassment, hazing, vandalism, theft, assault, and illegal acts resulting in police involvement.

WHEREAS, the Lakeview School District Board of Education represents the public's interest in providing educational programs in a safe learning environment that develop knowledgeable, healthy, socially responsible citizens in the global community; and

WHEREAS, members of the Lakeview School District Board of Education and administration have spent one and one half years dialoguing with and collecting information from students, parents, community members, coaches, and local and national health education experts to develop an athletic code of conduct that sustains district and community standards of excellence; and

WHEREAS, it is the Board's intent that the Code serve as a framework for expanding current efforts to ultimately provide the largest number of students possible with opportunities for growth and success by holding them accountable for the conditions set forth therein; and WHEREAS, the Board regards the Code as a living document that may benefit from further development during and after its implementation in order to preserve the philosophy and intent for which it was created;

NOW, THEREFORE, BE IT RESOLVED that the Lakeview School District Board of Education adopts this Athletic Code of Conduct as the definitive document expressing to student-athletes, parents, and coaches those expectations that are essential in upholding district and community standards for world-class athletes and athletic programs.

#### Sample Language – Board Approval

Athletes should realize that they are representing their school and community and should conduct themselves in an appropriate manner.

#### Adherence To Training Rules

Athletes must abide by the training rules as set forth by the Athletic Department.

#### AWARDS PRESENTED BY THE ATHLETIC DEPARTMENT:

- Athlete earning letter for the first time, receive "L" certificate, "L" letter, & sports pin. (varsity only)
- Athlete already earned letter in another sport, receive "L" certificate & sport pin. (varsity only)
- 3. Athlete earned letter in this sport before, receive "L" certificate & bar. (varsity only)
- Managers & captains receive "manager/captain pin". (varsity, JV, 9<sup>th</sup> grade)
- Certificate of Participation is given to all J.V. & 9<sup>th</sup> grade athletes. (Athletes who didn't letter on varsity team also fall under this category.)

#### AWARDS PRESENTATION

Each individual team/coaching staff will arrange for an end of the season presentation of awards. This should be done in as timely a fashion as possible following the conclusion of the season. Date and time needs to be approved through the Athletic Office.

### Sample Language – Legal

#### LEGAL RATIONALE

Athletic codes of conduct exist to ensure the health, safety, and welfare of the student-athlete and those he or she competes with and against. In <u>Vernonia</u> School District vs. Acton (1995), the Supreme Court of the United States of America held that drug-testing of athletes is permissible because students "voluntarily participate in interschool athletics" and "drug use by an athlete risks immediate physical harm to users and those with whom they play." For these reasons, further legal challenges to athletic codes of conduct have not been successful, even in the absence of drug-testing.

Whether one agrees or disagrees with the Supreme Court's position, the Lakeview School District is obligated, for legal and educational reasons, to maintain and require a "No Use" position when it comes to alcohol and drugs.

#### NORTHWESTERN HIGH SCHOOL TRAINING RULES

Revised: June 4, 2010

Participating in athletics is both an <u>Honor</u> and a <u>Responsibility</u>. Athletes are recognized for their achievements as representatives of their school and its ideals. Good physical conditioning and sound attitudes are integral to participation in <u>Northwestern's</u> athletic program.

It is a privilege to participate in athletics and this privilege is extended to all, <u>provided that students are willing to assume</u> <u>certain responsibilities.</u> A student participant must be a credit to oneself, the school, and the community. It is expected that all athletes will meet better than minimum standards in conduct.

The primary concern of the athletic department in encouraging athletes to refrain from the use of certain substances is the health and physical/psychological well-being of the athlete. A secondary objective is to ensure that the athlete properly represents himself/herself, his/her family, and the school. Additionally, the ability of the athlete to physically perform to the best of his/her ability should be maintained. The mental well-being, assistance in making quality decisions, resisting peer pressure, and development of self-discipline in the young individual is a consideration when issuing discipline.

Contestants' conduct in and out of school shall be such as (1) not to reflect discredit upon their school or the Association; and (2) not to create a disruptive influence on the discipline, good order, moral or educational environment in the school (Rule 8-C-8-1), Indiana High School Athletic Association.







#### Sample Language – Progressive Discipline

Category I Violations — Fighting, malicious or spiteful insubordination toward school
personnel, threatening or intimidating behavior and/or harassment of school personnel or
destruction of school property. Threatening or intimidating behavior and/or harassment of
another student in school or at any school function.

#### Penalty

- First offense: 10% of the consecutively scheduled dates (days) of the season during which the violation occurred effective immediately
- Second offense: 50% of the consecutively scheduled dates (days) of the season during which the violation occurred effective immediately.
- Third Offense: Suspension for one (1) calendar year from the time the principal or athletic director is notified of the infraction. Before reinstatement after serving the year, the participant must present a written letter to the athletic director explaining why he/she should be reinstated.
- Category II Violations Use or possession of tobacco in any form; use possession or under the influence of a controlled substance (other than prescribed by a physician) and paraphernalia related to those substances; consumption, possession or under the influence of alcoholic beverages; to steal or be an accomplice to the act of stealing.

#### Penalty

- First offense: 10% of the consecutively scheduled dates (days) of the season during which the violation occurred effective immediately
- Second offense: Suspension for one (1) calendar year from the time the principal or athletic director is notified of the infraction. Before reinstatement after serving the year, the participant must present a written letter to the athletic director explaining why he/she should be reinstated.
- Third Offense: Procedure will be identical to that of the second violation.

### Sample Language – Social Media

- Include a social media policy in your student-athlete code of conduct.
- Begin the policy with a statement of purpose explaining the disruptive impact of inappropriate social media postings on the school, on the athletics program, and on the morale and success of the team.
- Avoid generalized, morals clause type language in the policy.
- Include "participation is a privilege not a right" language.



## Sample Language – Social Media

- Include a social media policy in your student-athlete code of conduct.
- Begin the policy with a statement of purpose explaining the disruptive impact of inappropriate social media postings on the school, on the athletics program, and on the morale and success of the team.
- Avoid generalized, morals clause type language in the policy.
- Include "participation is a privilege not a right" language.
- Include precise language defining the specific prohibited behaviors:
  - Sexually explicit, profane, lewd, indecent, or defamatory language.
  - Derogatory language regarding school personnel or other students.
  - Comments designed to harass or bully students/school personnel.
  - Nude/sexually-oriented/indecent photos/images or altered pictures.



#### Sample Language - Social Media

Social Media - (Class II Infraction) Athletic Code of Conduct



Social media refers to internet-based applications designed to create and share user generated content. Any form of digital magazines, internet forums, web-blogs, podcasts, photographs, video, rating and social bookmarking found on websites or applications such as Twitter, Facebook, Instagram, or Tumblr that is open to public viewing is considered to be social media. This is a rapidly changing network as we move into the 21st Century, and many more not mentioned will arise, which are also included in this policy. Violations of this policy are subject to investigation and sanctions outlined in the Rocklin High School Code of Conduct (page 10) are also subject to review by state and federal law enforcement. These fall under Class II Infractions. Any and all disciplinary measures may apply depending on the severity of the infraction.

Rocklin High School student athletes are expected to conduct themselves in a respectable manner as a member of their teams and our Athletic program. As a student athlete you are responsible for your social media use. Any malicious use of social media platforms shall not be tolerated. Malicious use may include, but not be limited to:

- Derogatory language or remarks regarding fellow athletes, students, coaches, administrators, faculty and staff of Rocklin High School or other high schools.
- Demeaning statements or threats that endanger the safety of another person.
- Incriminating photos or statements regarding illegal criminal behavior, underage drinking, use of illegal drugs, sexual harassment or violence.

As a student athlete I have reviewed and carefully read, with my parent(s) / legal guardian, the Social Media Policy and agree to abide to all provisions contained within. Furthermore, I understand that a violation of said rules may result in loss of athletic privileges and/or suspension from participation.

### Sample Language – Drug Testing

#### **Drug Testing Policy**

The Huron School District believes athletes perform at their best when they adhere to good training habits. In order to insure our athletes follow proper training rules we conduct random drug testing of athletes 3 times per year. Test dates are unannounced and completely random. Tests are performed once during each season. Any athlete found to be using any illegal drugs becomes immediately ineligible for one week and in order to remain eligible must seek drug counseling for a length of time determined by the athletic department. #### Legal-ease, dot the I's and cross the T's

- Be mindful of **State Laws** and **District Policies** Prohibiting:
  - Discrimination in schools based on Sexual Orientation and Gender Identity
  - Bullying of students based on Sexual Orientation and Gender Identity

- Be mindful of Student Privacy regarding Sexual Orientation and Gender Identity
  - FERPA & HIPAA protect students against unconsented-to release of information in educational/health records, including transgender status
